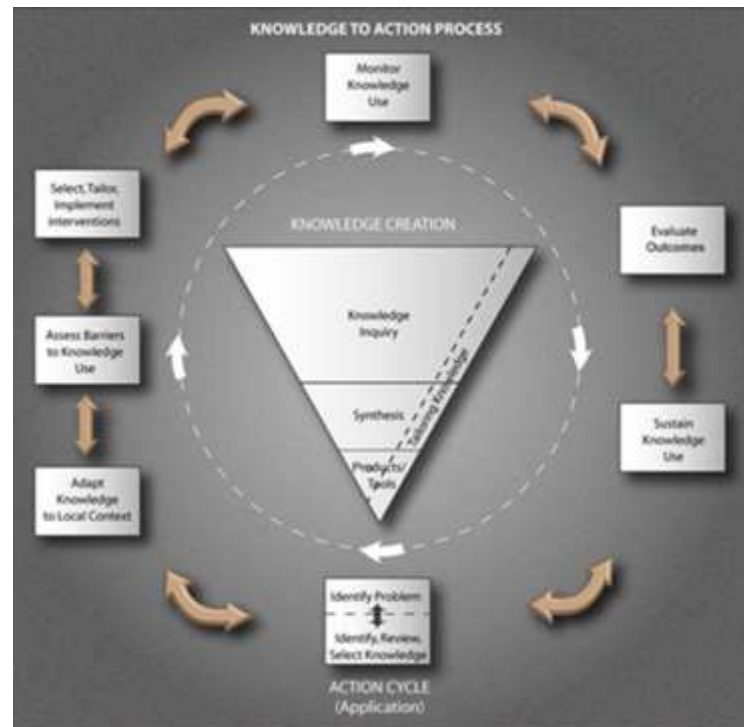
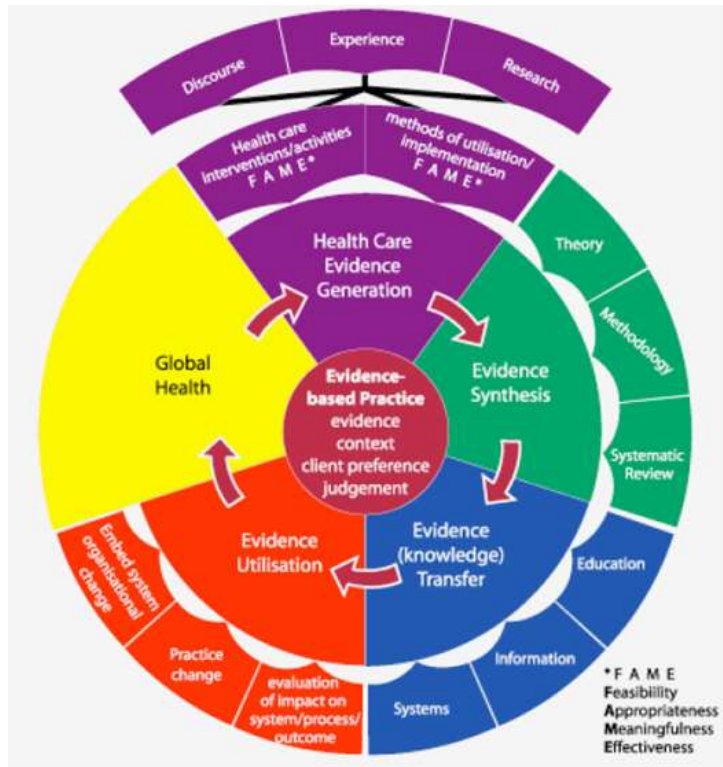


Project Objectives

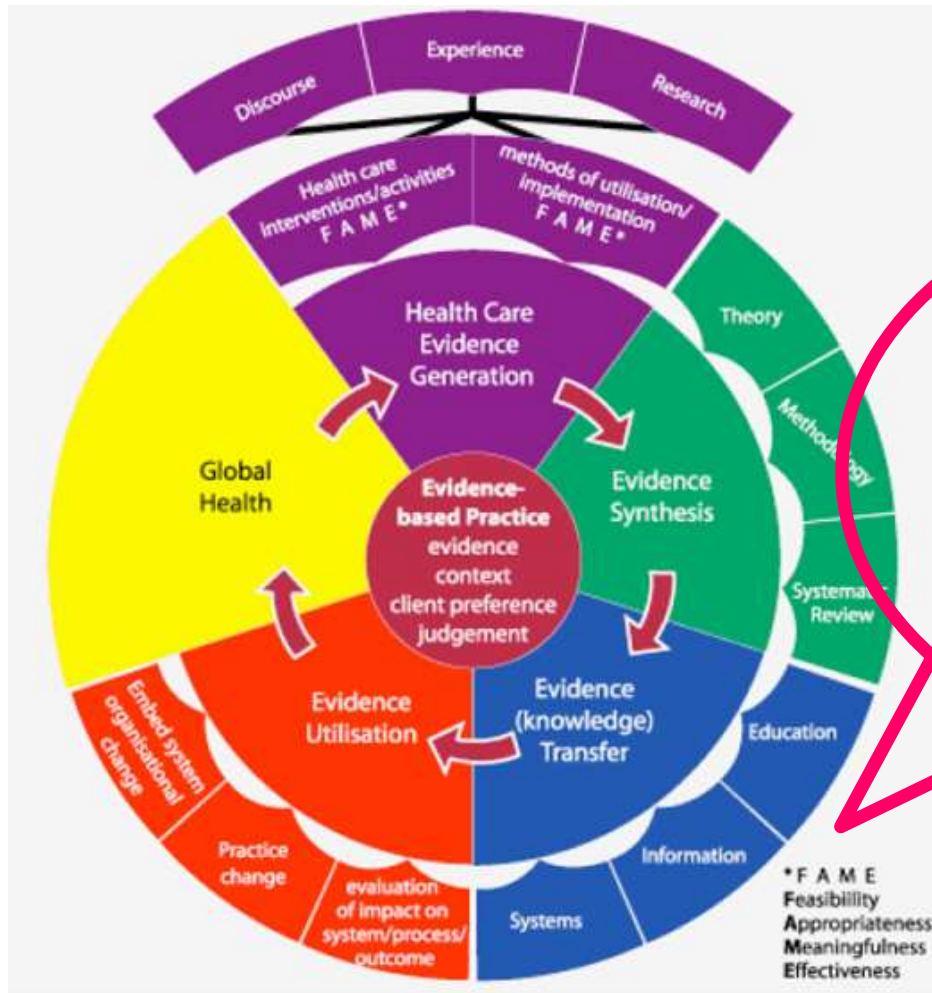
- 1) To describe the types of guideline implementation strategies used in the community health settings

KT Model/Framework

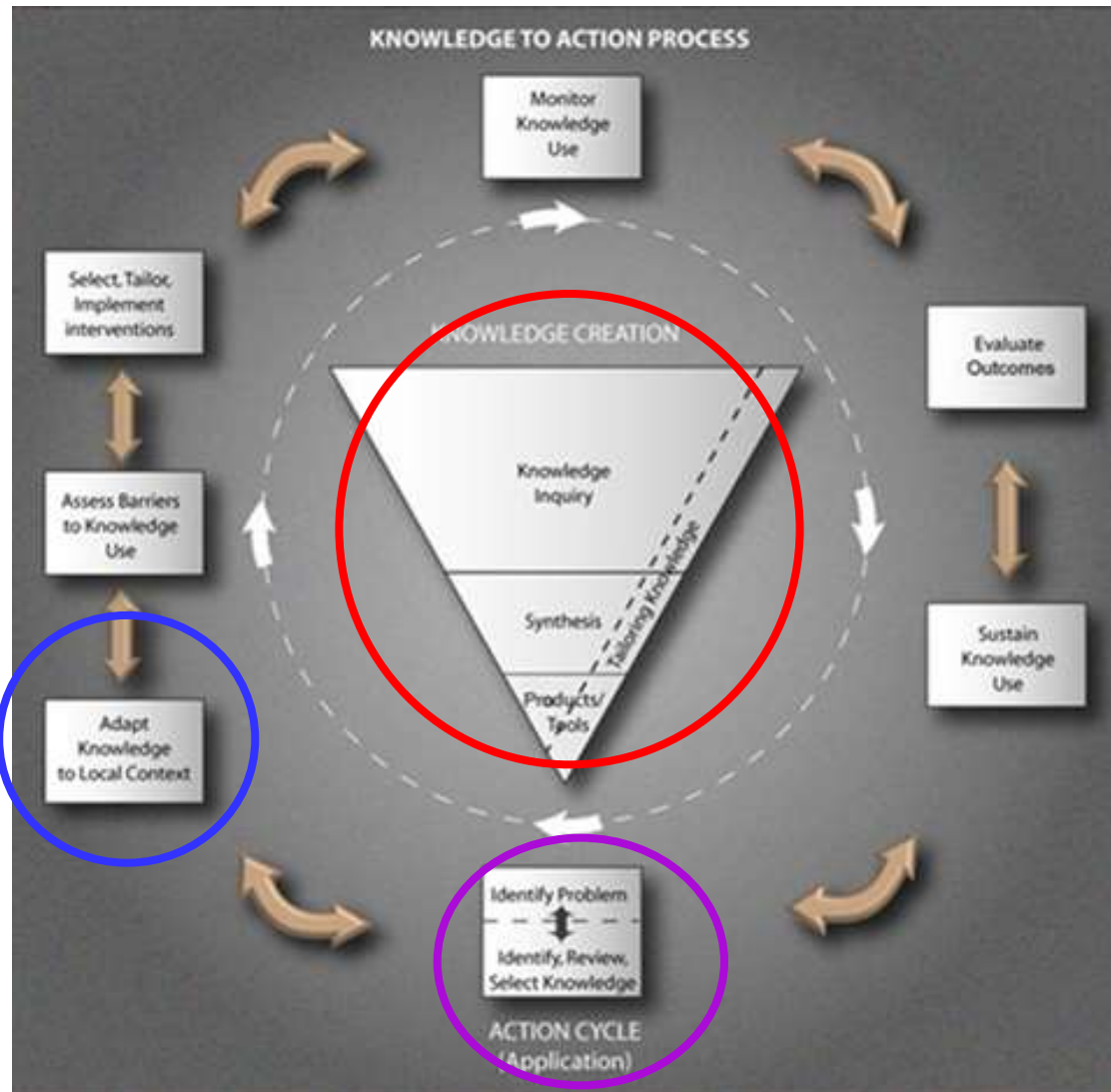


Joanna Briggs Institute Model

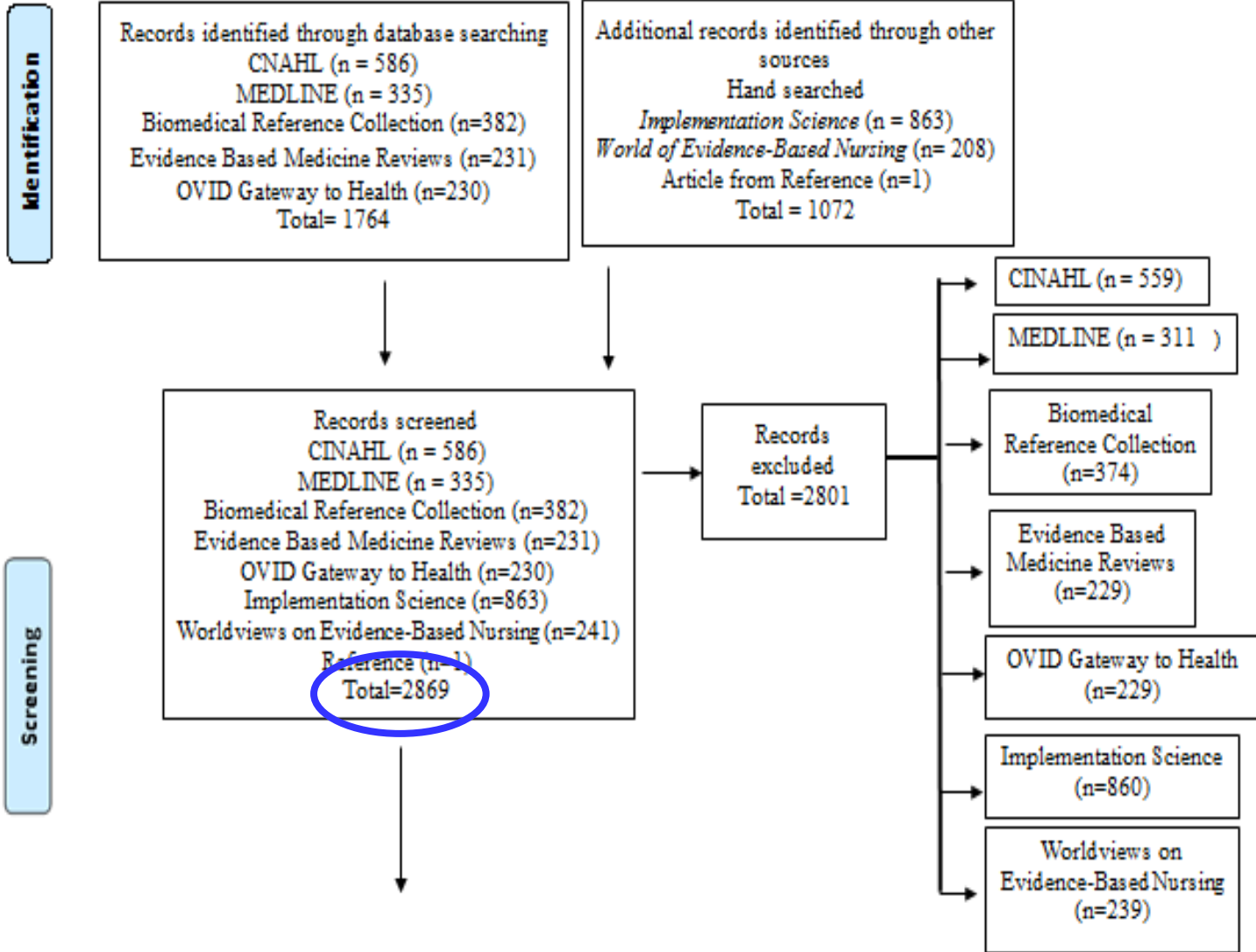


Development of Knowledge Synthesis Process

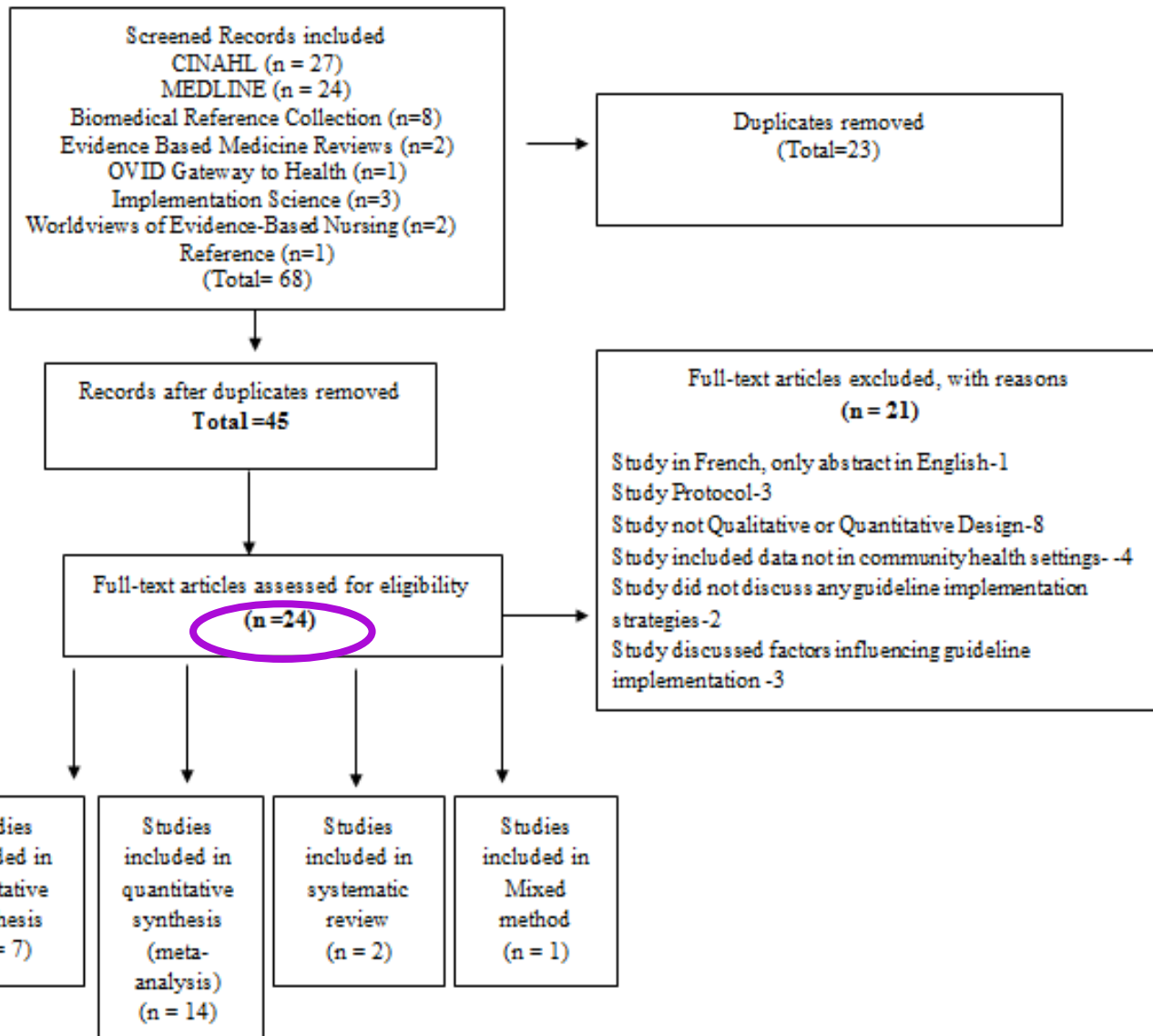
- Development of a systematic review protocol

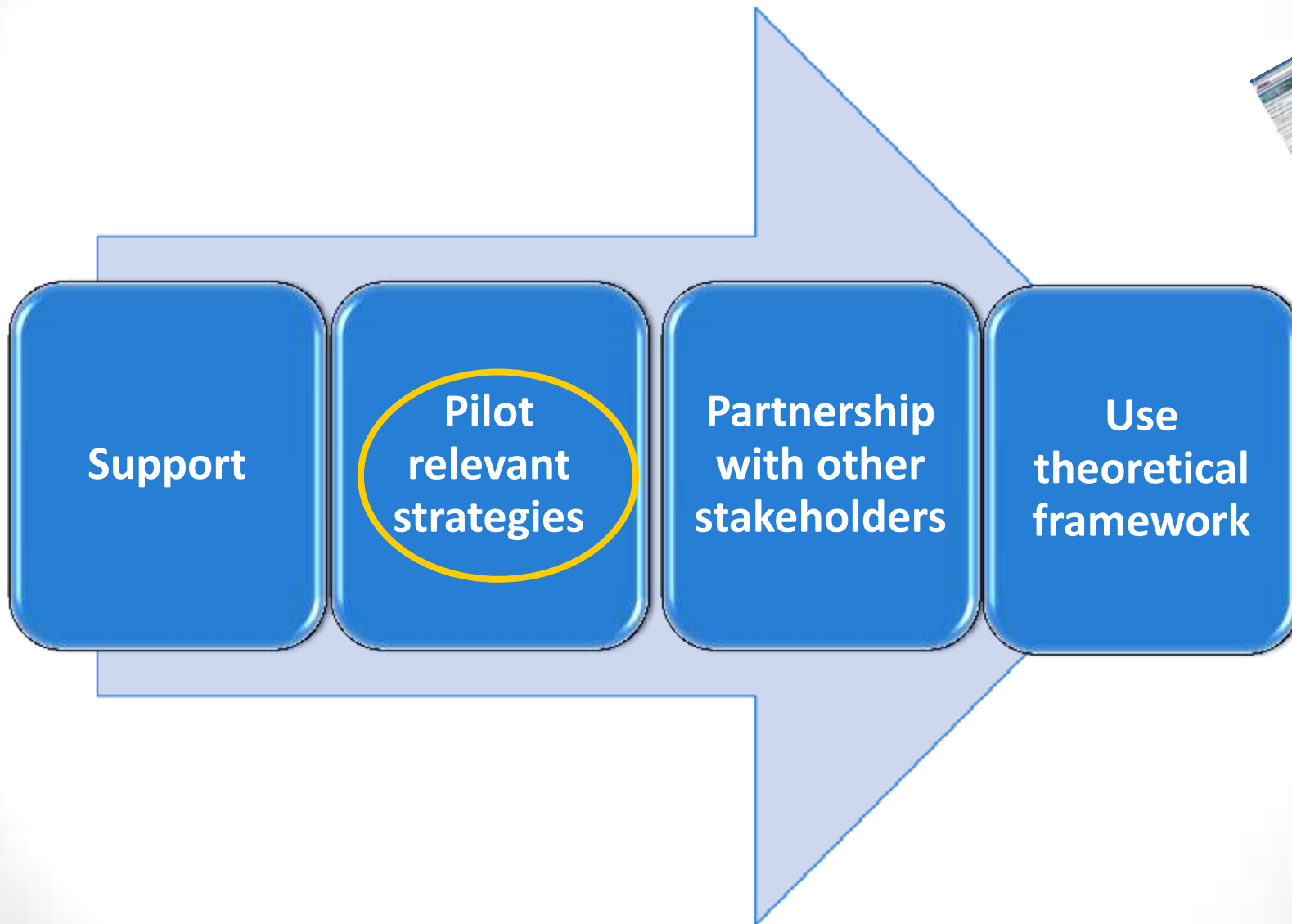

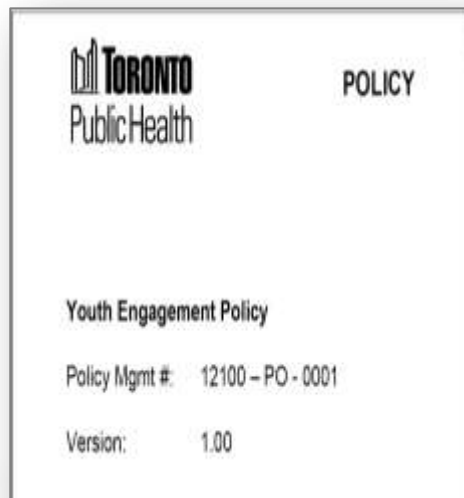
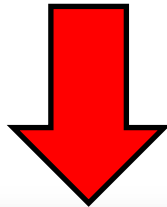
